

## Esky150 Vendor Requirements

### Insurance Requirements

All vendors must provide a Certificate of Insurance to: Esky 150 and the City of Escanaba, 410 Ludington Street, Escanaba, MI 49829. The Certificate must indicate at least \$500,000 General Liability Limits, and indicate "Esky150 activities in Ludington Park, July, 2013."

Insurance Certificate MUST accompany your application!

### Other Vendor Requirements

All vendors must agree to abide by the following terms:

- Food Vendors must provide two 50 gallon trash receptacles with liners, and service as necessary. Other vendors must provide one 50 gallon trash receptacle with liners and service as necessary.
- All vendors must obtain and possess a Transient Merchants License from the Escanaba City Clerk. Food vendors must be properly approved by the Delta County Health Department and possess proper certification and permits for the serving of food.
- Vehicles ARE NOT permitted on the grass! ONE VEHICLE may be used to set up and take down your unit, but only before or after vending hours.
- Park activities will be overseen by the Esky150 Committee, and vendor will abide by their direction.
- Vendors will remit an amount equal to 10% of their gross receipts from their participation in the Esky150 Celebration activities by July 31, 2013. Send payment to: Esky150, c/o Jeff Magowan, 823 Ludington Street, Escanaba, MI 49829.
